## Quarterly Update | Quarter ended 31 December 2016

This update covers the second quarter of FY 17.

### SURF 1 Distribution – Quarter ended December 2016 – 2.04 cents per unit

During the quarter the properties have performed as expected. The properties have required no maintenance or other capital payments and we continue to manage the drawn debt balance tightly resulting in a slightly lower finance charge compared to the PDS. These factors have contributed to enable the cash from operations available for distribution for the first and second quarter of FY 17 to be slightly increased to 2.040 cpu from the PDS forecast of 2.0175 cpu. This is equivalent to an annualised forecast FY 17 yield of 8.16%, and is an increase on the annualised yield in FY 16 of 8.08%, based on the cost of a unit of \$1.00. The next distribution will be for the period 1 January 2017 to 31 March 2017. We expect that the distribution for this period will be at least 2.04 cpu and will be paid by the end of April 2017.

### SURF 1 Property Valuation and Net Tangible Assets (NTA)

As at 31 December 2016 the valuation of the properties was \$64.8 million. Therefore the SURF 1 properties have increased in value by \$3.9 million since their purchase in October 2015. The increase in valuations is mainly due to a compression in capitalisation and discount rates. This has led to an increase in the NTA of SURF 1 to \$1.06 per unit at 31 December 2016 from \$0.95 at time of allotment in October 2015.

## ASIC Regulatory Guide 46 – Improving Disclosure

The following information has been prepared for SURF 1 for the purposes of ASIC Regulatory Guide 46.

<b>Disclosure Principle</b>	As at 31 December 2016 or for the 12 month period to 31 December 2016
<b>Gearing ratio<sup>5</sup></b>	Gearing of SURF 1 was 47.6%. This is less than the required maximum of 60% and the maximum of 55% to make a distribution or additional drawdowns. Gearing indicates the extent to which SURF 1's assets are funded by interest bearing liabilities.
<b>Interest cover ratio (ICR)<sup>5</sup></b>	ICR was 3.43. This is greater than the required minimum of 1.75. ICR measures the ability of SURF 1 to service interest expense.
<b>Interest capitalisation policy</b>	SURF 1 does not capitalise interest.
<b>SURF 1 borrowing</b>	SURF 1's borrowings are \$29.15 million which is less than the facility limit of \$30.45 million.
<b>Property portfolio diversification and valuation</b>	SURF 1 properties are listed above including key metrics. SURF 1's valuation policy requires all properties to be independently valued at least once every three years. The Inverell property was independently valued in December 2016. The remaining four properties were last independently valued in June 2015.
<b>Related party transactions</b>	Related party transactions have been disclosed in the PDS dated 16 July 2015 and in the financial statements for the period ended 30 June 2016. These are available on line at <a href="http://www.scaproperty.com.au">www.scaproperty.com.au</a> .
<b>Distribution practices</b>	Distributions are paid from cash from operations. It is anticipated that distributions will continue to be funded by cash from operations.
<b>Withdrawal practices</b>	Investors are unable to redeem their units. Subject to conditions, investors may privately arrange to transfer their units to third parties at any time using an Off Market Transfer Form. Please contact the Registry (details below) for further information.
<b>Net tangible assets (NTA)</b>	NTA per unit is \$1.06.

5. Gearing and ICR are measured in accordance with the definitions within the Finance Agreement between SURF 1 and the debt provider. Required maximum gearing and minimum ICR are also in accordance with the Finance Agreement.

SCA Property Group owns and manages quality sub-regional, neighborhood and freestanding retail properties.
